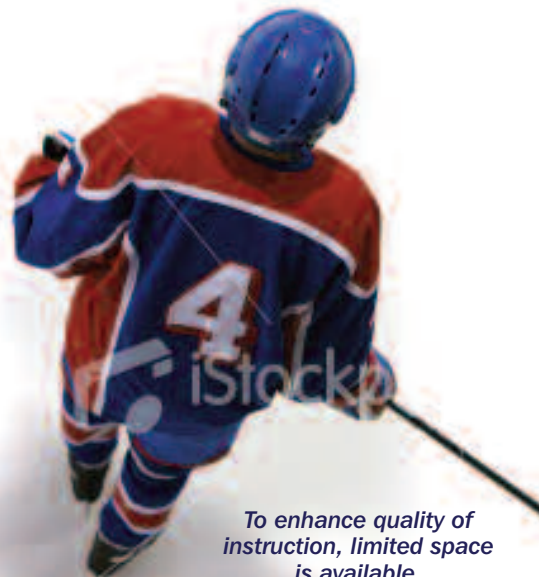

2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, of participation in the ROCHESTER HOCKEY ACADEMY CAMP, even if arising from the negligence of the releasees or others, and assume full responsibility for my participation, and

3. I willingly agree to comply with the stated and customary terms and conditions for participation in the ROCHESTER HOCKEY ACADEMY CAMP. If however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately, and

4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS the ROCHESTER HOCKEY ACADEMY CAMP, its officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and leasers of premises used to conduct the event. With respect to any and all injury, disability, death, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

5. Arbitration: In further consideration of allowing participation in the aforementioned activities, I hereby agree to submit to binding arbitration any and all claims which I believe I have against the releasees arising from my activities in the ROCHESTER HOCKEY ACADEMY CAMP. The arbitration shall be pursuant to the rules of the American Arbitration Association. The arbitrators shall apply the Federal Rules of Evidence to all proceedings. Arbitration shall be commenced within one (1) year from the date on which any alleged claim first arose. Further, the arbitration shall be held in the town where the CAMP is held, unless otherwise mutually agreed to by all parties. The submission to the American Arbitration Association shall be unlimited and the arbitration award may be enforced by any court of competent jurisdiction.
